



#### DETAILS OF THE AI COPY TRADER SERVICE” PROVIDER

By agreeing to this Limited Power of Attorney (‘LPOA’), the Client agrees to authorize the Amg Trade Service to act as his/ her/ their attorney-in-fact for the purpose of making use of the “AI Copy Trader Service” the Trading Company offers the Client. The “AI Copy Trader Service” will copy/follow/mimic the trades, scaled proportionally to the size of the Client’s account, made by the Trading Company’s main master trading account. The Client further authorizes the Trading Company to do anything further as may reasonably contemplated by the ‘Client Agreement’, ‘Terms and Conditions’ and ‘Order Execution Policy’ to effect this LPOA. Each live funded trading account of the Client for the purpose of making use of the “AI Copy Trader Service” of the Trading Company shall not be used by the Client for any manual or other trading. It should be noted that this LPOA (after engagement) becomes effective once the client toggles the option in trading account.

The Client consents to disclose to the Firm any personal information and trading related information reasonably necessary under this LPOA.

#### LIMITED POWER OF ATTORNEY

The Client understands and accepts that the Firm shall be sending instructions (via the “Copy Trader AI Service”) to the preferred Crypto Broker where the Client’s live funded account is held for the execution of Contracts for Difference (‘CFDs’) on Crypto exchange at their sole discretion, the Client ratifies such instructions. Therefore, the Firm, prior to execution, is under no responsibility to confirm such instructions with the Client.

The Client agrees that he/ she/ they shall indemnify and hold harmless the Firm, its officers, directors, employees, advisors, consultants or other partners from and against any loss and/ or liability that may arise in relation to this LPOA.

The Client is solely responsible for diligently monitoring his/ her/ their trading account and obtaining details regarding its overall performance.

The Client declares that his/ her/ their decision for allocating his/ her/ their trading account to the “Copy Trader AI Service” provided by the Firm is an informed one taken after carefully considering the risks involved in trading cryptos.

Amg Trade only have permission to trade on your account not withdraw/deposit.

#### REVOCATION OF THIS LIMITED POWER OF ATTORNEY

The Client may, at any time, request the revocation of this LPOA by sending an e-mail to [info@Amgtradeservice.com](mailto:info@Amgtradeservice.com) through his registered e-mail, given that there are no open positions. It should be noted that it is the sole responsibility of the Client to communicate the revocation of this LPOA to the Firm and request the closure of any open positions, if any. Such revocation of the LPOA shall become effective once received by the Firm, provided that the above mentioned conditions in relation to open positions have been fulfilled and communicated to the Firm. In addition, revocation of this LPOA may occur if the Firm or the preferred Crypto Broker where the Client holds the live funded account, for any reason, decides to terminate the Agreement between them.
